### **TERMS AND CONDITIONS**

- 1.1 The competition is only open to Australian-based Travel Agents working full time in an ATAS accredited Travel Agency. For the avoidance of doubt, if the Travel Agent works in an international travel agency with various offices and/or headquarters outside of Australia, only the Agency's Australian office(s) staff will be eligible.
- 1.2 All Airline employees (including Singapore Airlines & SilkAir employees), industry suppliers such as hoteliers, attractions and transport operators, Government organisations and regional, national and international tourist offices are ineligible to enter.
- 1.3 To qualify, correctly answer each daily question (15 in total) during the period 5 April – 28 April 2017 (the Period). The winner will be determined based on the most correct answers as well as the most inspired entry to the final question from all eligible entries.
- 1.4 Eligible Travel Agents must be a full time employee of an ATAS accredited Travel Agency in Australia for the Period. For the avoidance of doubt, if an employee ceases employment with the Agency between the Period and the date the Prize is drawn or at any time during the Period, they will be ineligible to receive the prize and SIA reserves the right to refuse awarding the prize.
- 1.5 In the event that SIA becomes aware of (or suspects) any fraudulent activity by the Travel Agent, or if the Travel Agent's Agency becomes insolvent, collapses or defaults between the conclusion

of the Period and the date the Prize is drawn, the Travel Agent will be disqualified and ineligible to win.

- 1.6 Travel Daily (TD) and SIA are not responsible for any technical malfunction of any communications network or any late, lost, incorrectly submitted, delayed, ineligible, incomplete data whether due to error, transmission or otherwise.
- 1.7 All entries will be tallied by TD and sent to SIA to review. SIA reserves the right, at any time, to verify Agent eligibility (including an Agency ABN, accreditation, identity and place of business) and to disqualify any Agent(s). Failure by SIA to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 1.8 SIA may request additional information from the Agency to assist in determining the winner. Agents must provide all additional information on request to facilitate.
- 1.9 SIA's decision will be final and any requests by the Travel Agent will not be entertained.

## **2. The prize**

- 2.1 There will be a total of one (1) major prize winner nationally. The major prize draw consists of two (2) Singapore Airlines return Business Class tickets from the winner's nearest Singapore Airlines Australian gateway (SYD, CBR, MEL, BNE, ADL, PER, DRW, CNS) to Stockholm.
- 2.2 Travel is valid on SIA operated services only and SIA's services to Stockholm commence from 30 May 2017.
- 2.3 The tickets are for travel in Business Class and non upgradeable.
- 2.4 The Tickets must be used in conjunction with one another i.e the two tickets that make up this prize cannot be used individually.
- 2.5 The tickets must be issued prior to 30 September 2017 and all travel must be completed on or before 30 November 2017.
- 2.6 Changes are not permitted after ticketing.
- 2.7 Travel is subject to availability at the time of booking. Travel is not permitted between during peak travel periods and blackout periods may apply.
- 2.8 Any portion of the tickets that remain unused after the expiry date shall be deemed null and void.
- 2.9 Tickets are valid for 3 months from the date of departure.
- 2.10 No Frequent Flyer miles will be accrued as part of this prize and not applicable for redemption upgrade.
- 2.11 A maximum of one (1) Travel Agent in Australia will be selected as the prize winner.

- 2.12 The prize will be awarded to the individual Travel Agent.
- 2.13 The prize tickets do not include Airport & Governments taxes, levies & charges.
- 2.14 The recipient is responsible for all travel costs to and from the point of departure, all meals, beverages, accommodation, ground transportation, transfers, extra activities, spending money, travel insurance, passports, visas, airport transfers, freight, excess baggage, all other ancillary costs or any other costs of a personal nature including items such as extra baggage or any other incurred expenses.
