1. General Terms

- 1.4 A pharmacy with the highest number of patient sign ups to App will be awarded each month
- 1.5 If there is a tie, an iPad will be distributed to each winning pharmacy
- 1.6 The iPad will be distributed from MedAdvisor Head Office

2. Who is eligible?

- 2.1 Entry is open to any MedAdvisor pharmacy who has active subscription/billing details with MedAdvisor and whose payments are up to date. (“you” or “your”).
- 2.2 You can enter or update your subscription details in the “**Subscriptions**” tab of the MedAdvisor program.
- 2.3 An “**eligible sign-up**” is defined as:
 - The patient is signed-up to MedAdvisor for the first time and if the patient was given an activation code, they must activate their account during the promotional period.
 - A patient who has signed up with an email and/or mobile using Instant Sign-Up or has activated their account using their Activation Code.
 - The patient must have a valid Medicare number or valid DVA number.
 - The patient has read and agreed to MedAdvisor’s Terms and Conditions.
 - The email or mobile number being used for the patient’s MedAdvisor account is the email address/mobile number the patient has chosen, the email address/mobile number is real and the email address/mobile number is only accessible by themselves or their chosen carer.
