CONDITIONS OF ENTRY

A. General

1. Information on how to enter this Promotion, mechanics of entry and prizes form part of these Conditions of Entry. Entry into this Promotion is deemed acceptance of these Conditions of Entry by each Entrant.
2. Entry is open to Australian and New Zealand residents aged 21 years or over who are employed as a travel agent for FCO or TMC Partners (Entrants). Travel Agents must be employed as a Travel Consultant at the same travel agency at which they were working when they entered this Promotion. If an Entrant ceases employment with their travel agency between the date they entered the Promotion and the date the Winner is decided, they will be ineligible to win and the Promoter reserves the right to select a replacement winner.

B. Entry

8. Eligible Flights means any new return flight booking between Australia and USA operated by Delta Air Lines or Delta code share operated by Virgin Australia booked between the promotion period .
9. For the avoidance of doubt, a booking will not be considered an Eligible Booking and will not count towards the Promotion where any of the following applies:
 - a. A deposit has not been paid within 14 days of booking;
 - b. The booking is subsequently cancelled, or the booking has been reissued prior to the completion of the Promotion Period; or
 - c. The booking contains incomplete, invalid, incorrect, cancelled or indecipherable codes.

22. The flight component includes premium economy class travel exclusive of taxes and fees from Sydney-Los Angeles-Sydney which will be issued on or after the group departure date. Taxes and fees will be quoted at the time of booking and must be paid by the winner. If the flight component has a destination beyond Los Angeles a stopover is not permitted
